I look forward to your participation in this year's annual conference!





## **Executive Committee Meeting Minutes**

White Duck Brew Pub – Winthrop, ME January 9, 2024

The meeting was called to order by President Quintal at 6:03.

**Legislative Committee** (Levi Ladd) – To aid discussions and provide an insight on what legislation MEREDA (Maine Real Estate & Development Association) is monitoring, Don Dostie provided the following report in an email prior to tonight's meeting.

#### Legislative Committee Report:

Dan Bernier has provided an updated list of Legislative bills being considered. As a member of the public policy committee with MEREDA, Don Dostie has been involved in discussions regarding the following bills: LD 772, LD 1134, LD 1257, LD 1672, and LD 1976.

LD 772 would bring more predictability to projects having received approval of their application being complete. This will stop after the fact moratoriums put in place for a specific project if the project meets current zoning requirements per the municipality's land use comprehensive plan. Years of efforts to design and submit applications for large developments at a substantial cost to the developers are subject to moratoriums voted on after approving the application when concerned local citizens rally against the project and put pressure on public officials to place moratoriums.

LD 1257 and LD 1134 are two bills looking to change the definition of subdivision allowing for "units" to be constructed within existing housing structures in urban-growth districts without going through subdivision. LD 1257 has many sponsors and more traction, LD 1134 is sponsored by Rep James Boyle, Gorham, who also happens to own Environmental Permitting and Inspection, LLC <a href="https://www.maine.gov/legis/housedems/boylej/index.html">https://www.maine.gov/legis/housedems/boylej/index.html</a> both bills have been carried over. Units numbering 3 to 18 could avoid subdivision with the changes. LD 1134 is much more aggressive in its amendments.

LD 1672 will establish an Affordable Housing Board at the State level allowing developers to bypass local planning and apply for permits through the new Board. There would be 7 members of the Board, 5 members, appointed by the Commissioner of Agriculture, Conservation and Forestry, 1 who works for the department, 2 from the affordable housing development or affordable housing finance industry, 1 from a municipal government, 1 who is an architect with building code experience and 2 trained in urban design that would be appointed by the Governor.

LD 1976 proposes amendments to Growth Management law's language with the goal of streamlining the approval process. The bill redefines "affordable housing" and outlines multiple districts in support of LD 2003 which was passed last year. In conclusion, there is a lot of momentum to increase affordable and middle-income housing within the State of Maine. Several of the bills outlined above attempt to stream line the process of approving projects and increase housing even so far as to create a State Board that would override local planning boards and staff providing a permitting process at the State level. While he can't go into too much detail about discussions held at MEREDA due to confidentiality requirements of members on the committee, MSLS should be paying attention to these bills and support affordable housing efforts as well as bringing more predictability to the approval process. We make no recommendations except that MSLS should support LD 772 and LD 1976 while following closely developments on the remaining bills as they go through workshops. These are in Dan's updated list.

At the ExCom meeting, Dan spoke about some proposed subdivision law changes. LD 1672 would establish an "Affordable Housing Development Review Board" to issue permits for the development of affordable and workhouse housing. Dan mentioned that the Maine Municipal Association (MMA) is having some issues with this bill. Don pointed out that this bill would likely have to go through appropriations at the Legislature because there would be a fiscal note attached due to the establishment of a new board. Don also added that he has concerns that the current proposed make-up of this board does not include a surveyor or civil engineer. LD 1787 is a resolve to create a stakeholder group "to review and recommend a comprehensive overhaul and modernization of subdivision laws". Dan said that tone in Augusta and the wording of many of the bills aimed at increasing housing supply in Maine are pushing Maine toward some loss of local control at the municipal level. LD 1685 would change the acreage

eligibility requirement from 10 to 25 acres of forested land for the "tree growth" tax credit. Dan said that the Judiciary Committee had a few flood zone questions on LD 2035. That bill would require property sellers to notify in writing whether a property is in the flood zone, and/or has incurred flood damage, or filed flood claims while the seller owned the property. Dan was at the committee hearing for another organization he mentioned that MSLS could answer those questions.

Dan's list of pending legislation that he is monitoring is emailed to members regularly. If you are not receiving them, contact Bruce Bourgoine to make sure he has your email address. LD 226 – "An Act to Address Maine's Affordable Housing Crisis" was assigned to the Labor and Housing Committee. No hearings or workshops have been scheduled.

LD 240 – "An Act to Increase Public Access to Utilities" has been assigned to the Energy, Utilities and Technology Committee. A public hearing is scheduled for Jan. 9<sup>th</sup>.

LD 371 – "An Act to Address Certain Local Zoning Ordinances" was assigned to the Housing Committee. A workshop is scheduled for January 9<sup>th</sup>.

LD 772 – "An Act to Establish a Process to Vest Rights for Land Use Applicants" was assigned to the State and Local Government Committee. A workshop was held on Jan 5<sup>th</sup>.

LD 1134 – "An Act to Improve Housing Affordability by Amending the Definition of 'Subdivision' Under the Site Location of Development Laws" was assigned to the Housing Committee. A workshop was held on January 5<sup>th</sup>.

LD 1787 – "Resolve, Directing the Department of Agriculture, Conservation and Forestry to Convene a Stakeholder Group Tasked with a Comprehensive Overhaul of the State Subdivision Statute" was assigned to the Environmental and Natural Resources Committee.

LD 1864 – "An Act to Increase Maine's Housing Supply by Prohibiting Certain Zoning Requirements in Areas Where Public Sewer and Water Infrastructure Are Available and in Designated Growth Areas" was assigned to the Housing Committee. A workshop is scheduled for January 12<sup>th</sup>.

LD 1976 – "An Act to Update the Growth Management Program Laws" was assigned to the Housing Committee. A workshop is scheduled for January 12<sup>th</sup>.

LD 2003 – "An Act to Protect Access to Maine's Intertidal Zone" was assigned to the Marine Resources Committee. A Public Hearing is scheduled for January 11<sup>th</sup>.

LD 2030 – "An Act to Exempt Certain Emergency Activities and Structure Elevation Increases in Flood Zone from Permit Requirements Under the National Resources Protection Act" was assigned to the Environment and Natural Resources committee. A Public Hearing is scheduled for January 10<sup>th</sup>.

LD 2034 – "An Act to Address Identified Gaps in Laws Governing Erosion Control and the Natural Resources Protection Act" was assigned to the Environment and Natural Resources Committee. A Public Hearing is scheduled for January 10<sup>th</sup>.

 $LD\ 2035$  – "An Act Regarding Disclosure of Flood Risk by Sellers of Real Estate" was assigned to the Judiciary Committee. A Public Hearing was held on January  $3^{rd}$ .

LD 2087 – "An Act to Protect Property Owners by Preventing the Use of Eminent Domain to Build Transmission Lines Under the Northern Maine Renewable Energy Development Program" was assigned to the Energy, Utilities and Technology Committee.

LD 2101 – "An Act to Strengthen Shoreland Zoning Enforcement" was assigned to the State and Local Government Committee.

**Secretary Report** (Kevin Farrar) – The minutes from the December 12<sup>th</sup> meeting held at the Sebago Technics in South Portland were accepted as printed. Motion to accept was made by Jimmy Courbron, seconded by Wayne Wood and approved unanimously.

Treasurer's Report (Jimmy Courbron) – Jimmy said that we currently have \$20,864.92 in our checking account. The Vanguard account (scholarship fund) as of today contains \$208,140.72. An "end of year" profit/loss report and the 2024 proposed budget is in the meeting materials. Jimmy said that the profit/loss report shows a positive result for 2023 mostly due to some money in the B&B fund and about \$600 placed in the miscellaneous income budget column from an overdue collection on 2022 dues. Moved to accept the Treasurers report by Wayne Wood, seconded by Karl Olson, passed unanimously.

**Executive Dir. Report** (Bruce Bourgoine) – Bruce's report is below. He added that he's been focused on the annual meeting. He said that it Is too early to tell on whether registrations are running ahead or behind.

There is one new applicant for membership, Todd Chapman (associate). It was moved to accept Todd as a member by Wayne Wood, seconded by Karl Olson, and approved unanimously.

**Education Committee** (Deborah Briggs) – No report.

Scholarship Committee (John Lloyd & Steve Gould) – John emailed a report with the following information (names removed until awards are given) - The Scholarship Committee reviewed three applications for 2024 MSLS Scholarships. The committee recommends that two applicants receive MSLS support. The third applicant is a new student and does not currently meet our requirements. That said, we should strongly encourage the third applicant to reapply next year, as he appears to have the makings of a fine student and surveyor.

The Committee recommends that MSLS award \$2,500 to one student and \$1000 to the second whose applications were accepted.

The Committee is concerned by the small pool of scholarship candidates. To that end, we have been discussing changes to our requirements that would expand the pool of eligible candidates to more "non-traditional" students. It is our hope that we can provide more awards in future years, of similar size, increasing the overall disbursement. Our fund is healthy, growing, and has the capacity to support these goals.

We will have more to share in our Annual Report in a few weeks. Please let us know if you have any questions.

The discussion at ExCom began by focusing on how few applicants there were. Jimmy Courbron and President Quintal talked about efforts MSLS has made with UMaine faculty, the UMaine Student Chapter to get students to fill out the application. Our residency requirement may be a limiting factor, but there has got to be many more than 3 students who are Maine residents in the SVT program.

Bruce Bourgoine reviewed our scholarship rules/bylaws and indicated that the "new student" rule was an ExCom policy and not an MSLS bylaw. Jimmy Courbron moved that we waive the new student/freshman policy so that the application can be property reviewed by the scholarship committee. The motion asks the committee to provide ExCom with a recommended scholarship reward amount for the third applicant not to exceed \$2500. The motion was seconded and passed unanimously.

Matt Ek moved to follow scholarship committee recommendation on the other two applicants. The motion was seconded and also passed unanimously.

**Benevolent & Betterment Fund Committee** (Matt Ek) – After a brief discussion about a local surveyor in need, Don Dostie said that we are going to need to establish policy on how to manage this fund. It was decided to have a workshop around March.

**Historical Committee** (Tom Blake) – No report.

Program Committee (Steve Gould & John Lloyd) – The 2024 MSLS Annual Meeting will be held Thursday February 1<sup>st</sup> and Friday February 2<sup>nd</sup> at the Regency Hotel in the Portland Old Port. On Thursday, the professional track will feature Linda Foster, ESRI Global Manager of Land Records and NSPS Vice President who will give a presentation titled "National update and what's happening in surveying across the globe". Richard Brooks, Senior Project Manager with Control Point Associates will be speaking on "Ethics for Surveyors". Rich Vannozzi, UMaine SVT Professor, will be speaking on the "Top 10 Practical Lessons for being an effective Land Surveyor in Court" and Dan Bernier, Esq. and MSLS Legislative Liaison will be speaking with Craig Young and Elizabeth Frazier (MEREDA) with a "Legislative Update and Outlook". The Thursday technical track will include equipment presentations by Spillers, Maine Technical Source, Keystone Precision Solution and TopCon. **Board of Licensure** (Levi Ladd) – The December 17<sup>th</sup> meeting was cancelled due to a snow storm. The next meeting is scheduled for January 30<sup>th</sup>. There are currently multiple vacancies on the board. Bruce asked about whether MSLS should be trying to recruit a surveyor to nominate to the Board through FieldNotes. It was decided that Don Dostie would work with Bruce to create a "help wanted" style advertisement/listing to place in FieldNotes.

NSPS (William Shippen, Director) – No report.

**SVT at UMaine** (Stephen Gould) – No report.

Central Maine Community College (Cassandra Quintal) – Cass said that the class wrapped up last week. They ended with 11 "graduates". The next one starts in April. There have been a few equipment donations and a couple of CST applicants. CMCC is currently working with Tara Mullen (instructor) on a way to lead the course remotely from SMCC, as she lives close to that campus.

**FEMA** (Mark Carpenter) – No report. Matt said that he heard Cumberland County will accept the proposed FEMA flood maps by July.

Wayne Wood moved to submit the budget as edited to the general membership. Seconded by Don Dostie, passed unanimously.

WAYNE- **Peter L. Ault**, 92, passed away at Central Maine Medical Center in Lewiston after a brief illness on Thursday, August 10, 2023, with his loving sons by his side.

Born in Lewiston on January 31, 1931, to the late Charles and Ruth (Dobson) Ault, Peter was the seventh of ten children. Childhood was at Cushman Place in Auburn, where Peter attended Auburn schools. Summers were spent in Wayne; in the summer of 1942 the family moved to Wayne year-round, and the Auburn city kid became a country boy.



Peter attended Wayne School for 7th and 8th grade and then went to Winthrop High. In his junior year he was sent to The Manlius School, a military school where, according to him, he learned to march. He graduated from Manlius in 1948. He graduated from Bates College in 1952 with a bachelor's degree in history.

Upon graduation he was drafted into the Army and was shipped off to the Korean War. Korea was a very formative experience. He often reflected that the homeless starving refugee families he saw in all of the bombed cities between Seoul to Pusan gave him lifelong gratitude for the gifts of family and peaceful beauty of Wayne, Maine. He was also grateful for his education, which saved him from being sent to the front lines. When the hundreds of troops on his transport ship landed in Korea and were first assembled, the commander asked the troops if anyone could type. Peter was the only one to raise his hand. He was ordered to stay behind to type orders and the rest of the troops were sent north to the front lines. While in service, already knowledgeable in the care of farm equipment, trucks and cars, he also received training in the maintenance of military vehicles.

Peter's career at the State of Maine Bridge Division began in the soils lab in 1962. He went on to be the Resident Engineer on bridges all over the State from the Penobscot in Sherman, to the Fore River in Portland. He especially enjoyed working on the restoration of many of Maine's historic covered bridges. He retired from the State after 34 years in 1995. He continued to work as a bridge engineering consultant until 2013 on projects including the Maine Kennebec Bridge and the Augusta Traffic Signal Systems.

Peter enjoyed giving back to the community he loved. He served on the Wayne Planning Board, Selectboard, as Town Treasurer, as a Library Trustee, on the Historical Committee, Memorial Day Committee, Conservation Commission and 30 Mile River Watershed Association.
